- 2) In the event of Fine Young Africans cc instructing its Attorneys to collect any overdue amounts, all legal fees and collections between Attorney and Client shall be borne by the Customer and all payments made shall be allocated firstly towards such fees and charges thereafter to interest, and finally to capital.
- 3) The Customer hereby consents to the jurisdiction of the Magistrates Court for all actions which may be instituted against it for the recovery of any amounts owing to Fine Young Africans cc Consent to jurisdiction of the Magistrates Court in respect of all amounts or causes of action arising out of supply of goods and which would otherwise be beyond the jurisdiction of the Magistrates Court. Due to the amount of the claim, such consent being in ten11S of the provisions of Section 45 of the Magistrates Court Act.
- 4) The signatory/ies, hereto, binds himself/herself/themselves jointly and severally as surety and co-principal debtor/s in solidium with the customer unto and in favour of Fine Young Africans cc its order or assigns, for the due performance by the Customer of all its obligations to Fine Young Africans cc.
